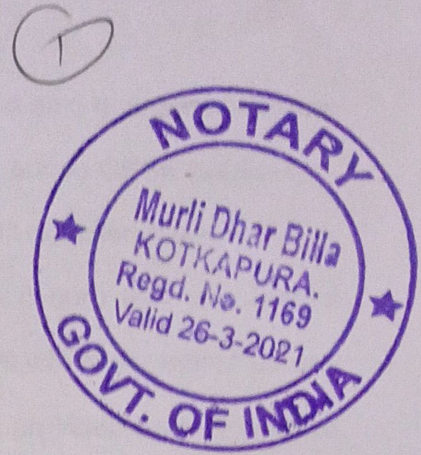

2. Punjab Govt. issues no objection certificate on the under stated conditions after thoroughly considering the recommendation of District Education Officer (Sec. Edu.) Faridkot and Director Education Department (Sec. Edu.) Punjab, Chandigarh on the affidavit and documents presented by the Management of the School.

1. NOC will be taken back anytime, if it is found in future that wrong information was presented by you at that time of inspection or complaint is done against you and it is observed that wrong information was provided by you at the time of issuance of certificate and you don't abide by the instructions issued by Punjab Govt. from time to time and the conditions stated in affidavits are not met by you, then in such conditions NOC will be taken back.

2. Your school will compulsory teach Punjabi upto 10<sup>th</sup> class level and CBSE New Delhi will compulsory initiate the act of taking Punjabi exam in 10<sup>th</sup> class and it is also stated along with this that if this is not done this NOC will be taken back.

3. Under RTI Act 2009 all notifications and RTI Act 2009 formulated for Punjab Govt. the school Management will observe the rules.

4. The school management will compulsory pay and also give allowances to teaching and non-teaching staff like govt. employees after taking CBSE application, through account payee cheques, it is not done then NOC will be taken back.

5. You yourself and your management will make it sure that you District Education Officer or Senior Official of Education Department whenever asked for any kind of information then the necessary information will be provided and all needed help will also be given. If this is not observed NOC will be taken back.

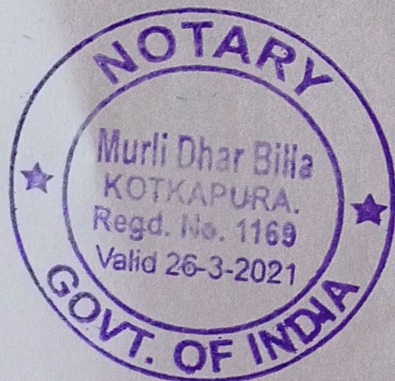
