Sub:- Under the Right to Free and Compulsory Education for children Rule 2011 of sub rule (4), for the getting letter of recognition for school for serving the purpose free and compulsory Education for children Act 2009 Section 18

Sir/Madam,

Your request letter and later on through letter/with reference of inspection to the above Rishi Middle School, Panjgrain Kalan had been given affiliation from class first to eighth upto dated 1.4.2016 to 31.3.2019. For the purpose of fulfillment of Right to Free and Compulsory Education Act 2009; the following conditions are needed to be fulfilled:-

1. The permission for granting of affiliation is not applicable for increments and in any condition its meaning should not be taken that it is compulsory for getting affiliation for classes above Eighth standard.
2. The school shall abide by the right to free and compulsory education for children Act 2009 (Table-I) and Free and compulsory education rules 2011 (Table-II) and their subsections thereof.
The school shall give admission to children of weaker and non facility sections who live around the school area that in class 1st (or previous school, which shall be applicable those children should account for 25% of the total children in the class and will provide free and compulsory primary education to them until its completion.
3. According to provisions of subsections (2) of section 12 of act for children provided in Para 3 the incurred cost will be provided. The school will maintain a separate bank account for getting appropriate funds for the purpose.
5. The institution/school will not take any capitation fee for the purpose and will not take up any method or way of choosing the parents or children their guardians.
6. The school will not refuse admission to any child in case of not having proof of date of birth and will abide by the subsection 15 and its provision of school will ensure that-
 - (i) Any child once granted admission in a class shall not be obtained in the same class for next year also or any child will not be rusticated from the school until his/her primary education has been completed.
 - (ii) No child will be provided corporal punishment or any mental tension in anyway.
 - (iii) No child has to pass any board exams until the completion of the primary education.
 - (iv) Every child who has completed his/her primary education, will be granted certificate according to rule 25.

- (v) The education will be inclusive that is according to provision of the Act the special children or disable children will be included school education.
- (vi) It is necessary for teachers that they must be provide minimum qualification eligibility according to section 23 (1) but the further condition is applied that the present teachers who are employed presently at the time of application of this act and they are not able to fulfill the minimum eligibility criteria within a period of 5 years, they must acquire the minimum qualification eligibility.
- (vii) The school will provided curriculum according to the pre-decided syllabus decided on subjects of the study on the basis of syllabus sanctioned by the authority.
- (viii) The school shall abide by the conditions and fundamentals provided in section 19 of the Act.

- (ix) The school should be run any classes which have not been granted affiliation in school premises or outside of it.
- (x) The school building or other premises or its playground will only be used for the purpose of education or competency development of skills only.
- (xi) The school is being run by the trust under school society registration Act 1860 (1860 of 21) under the registered societies or under the laws enforced from time to time.
- (xii) The school is not being run by some private, group or people for the purpose of financial gain.
- (xiii) The accounts should have been audited by Certified Chartered Accountant and the statement of accounts will be prepared according to rules. One copy of the account schedule will be sent every year to District Education Officer.
- (xiv) The affiliation code of your school is SSE/RTE/2016-17/26. This should be noted and it should be noted in every time while correspondence through letter with this office.
- (xv) The school shall present the information required by the District Education Officer from time to time and school will obey all the rules and regulations provided by appropriate authority or district education officer, which shall fulfill the conditions of affiliation granted or those who shall remove the deficiency within school.
- (xvi) The school shall make it sure that the school's registration or some renewal of necessary then it should be done.
- (xvii) You fulfill all the terms and conditions mentioned in the self-declaration letter/undertaking. If your self-declaration letter/ undertaking is found to be incorrect at any time then appropriate action shall be taken against you under the Right to Free and Compulsory Education Rule, 2011.
